# Committee meeting held Redcar RAFA club, Wednesday 29th June 2011.

1/6c/11. The chairman opened the meeting at 1930 hrs.

## 2/6c/11. Treasurer.

The treasure started by making a statement regarding an item he had heard about, that stated he had told ex-member B. Macintyre to put money in his pocket. The treasurer refuted this allegation and told the committee that he had brought the branch books up-to date and would leave his position as branch treasurer.

The chairman stopped mutters going around the committee and called for a vote regarding the treasurer. A vote of confidence was taken by a show of hands, and was unanimously in favour of the treasurer. Following this it was revealed that other stories were in hand regarding [B.Macintyre] involving money, and that the branch was well rid of him.

## 3/6c/11. Branch Rep.

s/m Billy Dobson reported firstly about his connections through his family with the MN.

2nd. He had already reported about the national council meeting. (March)

3rd. That the branch review of the MNAs constitution was now completed and had been forwarded on the national office.

4th Billy raised concern regarding several items on the agenda of the coming national council meeting (2nd July) and a couple points of order to be raised. These are in relation to a letter from the Bristol branch regarding attendances at AGMs, and items from national vice chairman Malcolm Mathison on rules 7, 8 and 9 on age qualification for membership. Yet for all the work carried out by our branch [Dormanstown/Redcar] was not even mentioned as well as a letter of complaint sent in regarding the last national meeting.

6th Seafarers Awareness Week commencing 6th June regarding sea blindness should be continued with the library display, to make the general public more aware of the need for shipping.

7th Billy gave an up-date on calendar sales, and commended s/m Jan Harper [Welfare] for the sales she has already made. Also Coasters are now available with the branch badge on them.

8th Billy has been in contact with James Godbold regarding the Birger anchor plaque and it will be stored at Egton until required

9th Billys work regarding the audio library for members with poor eyesight, he reported that his cataloguing of books now totals 1,973 that includes novels, short stories and poetry covering 552 authors.

## 4/6c/11. Welfare Officer.

The Jan Harper reported to the committee on her visits to s/ms Peter Willis, Vilma Collins, Brian Warrior, she said that they are all doing well and send their regards to the branch.

The Welfare Officer was again thanked for her commitment to the position she holds within the branch.

## 5/6c/11. Any Other Business.

## 5.1 Branch Plaque for Reunion.

The Sec, showed around the embroidered plaque received from Hull IMNA at Bridlington. It was agreed that the branch would do likewise for the next gathering.

He reported that s/m Jack Robsons wife (Margaret) could do the writing part on the material but, we would have to go to Quick stitch to see if the MN badge could be done. It was agreed that this work would be done and the sec. will make enquires to having the work carried out.

#### 5.5 Merchant Navy service 4th September.

It was agreed that the pecking order for wreath laying at the Garden of Remembrance would be left to the Sec and Billy to sort out. With there being a change to the venue the sec. reported that he had sent out letters to the usual guests and so far had received several replies, but more was to be done before the service sheet was put together.

# 5.6 Branch Half Year Reports.

#### 5.10 Data Protection.

The sec, told the committee that he had attended Redcar Police Station that day to make enquiries regarding Data Protection and the branch Welfare Officer. The Police had given the sec. a phone number to ring at Data Protection, who in turn had stated that there was really no need to have Jan checked out and that it was up to us or not if we wanted to go ahead. When it was mentioned that we are part of a charity that, was a different thing, so, the sec. had asked the national office about this item. They in turn said they were attending a MNWB meeting and they would ask there, but it was a very good question that had been raised by the branch. This item had been brought to the secs. attention by Jan herself because she is entering peoples homes and that is seen as dealing with vulnerable people. Several questions were asked regarding this matter, and the sec. said that every year when he applies for a permit from Redcar & Cleveland council to hold a street collection. We are checked out! In answer to a question from s/m Cyril Kitchener, the sec. said he was keeping the branch legal and shutting all open doors.

### 5.11 Standards on Parade.

s/m Jan Harper asked if the branch had been approached by the Redcar Workingmens club about the Standards being on parade in the club on a night to be agreed. This is in connection with Help the Heroes

Subsistence for other matters ie members attending council meetings etc would remain at £10. All Agreed.
