1/9c/11.

The chairman opened the meeting at 1930 hrs.

Apologies from s/m's John Cook and Noreen Sowden.

2/9c/11. Correspondence.

The secretary only related to two items of correspondence, both were in relation to the September branch meeting. The first letter was from the secretary to the chairman about the negative attitude within the branch and opened the letter, “ This letter is not my resignation, but, it is the one before it.”

The second letter was from s/m Ian Barnes also in relation to the September branch meeting. Ian outlined what people were doing to better this branch, and that there was a negative attitude.

5/9c/11. Branch Welfare officer.

6/9c/11. Branch Public relations officer.

S/m Tony Whatmore thanked Billy Dobson for his kind words thanking him for the work he was putting in with public relations. Billy had made it quite clear that people had read the snippets of information in the press. Also brought to the attention of the committee was that Craig Colebrook of the tourist information office was another outlet for the branch. Tony also stated that 'knowing the treasurer was looking for someone to take over the running of the 25 club, he was prepared to do it.'

7/9c/11 Any Other Business.

7.1 Ladies section.

With regard to the proposed ladies section within the branch, the secretary said he was going to push on with the idea regardless of any negative attitude. The secretary then went to read out the 8 point law on the ladies section that will be entered into the branch constitution.

S/m Raymond Coaster thought that it should be brought up at the next branch meeting again to let the ladies of the branch have there say on the subject. Raymond also went on to tell how monies within the branch were moved around into there own accounts.

7.2. Branch constitution.

The secretary reported that, not only was he writing up the articles on the ladies section, but he was also wanting to open the branch constitution to make an entry under finance that would allow the branch to move money from the branch 'Welfare and Remembrance fund' into the general account.

Last year we had moved £500 in this manner as the general fund at that time was getting low. The secretary said that this was another one of those items that he works on to that will keep the branch legal at all times.

The secretary also hopes that the the branch constitution will be renumbered in time for the branch AGM in January 2012, so that it can be fully ratified.

7.3 Branch Memorial book.

The secretary passed round the meeting a new branch Memorial book that he had done for branch members, plus another book that would be for all the other names that were in the old book.

7.4 Branch Photograph.

With regard to having a branch photograph taken, s/m Billy Dobson told the committee that he knew a photographer who would do the shot for £95 plus the cost of each separate photograph for each member. The secretary said the last photo was taken back in 2007 and that had cost £100 and £5 for each photo after that.

Chairman s/m Dave Price said the ideal time to have this done would be in the spring of 2012 when nights are pushing out as some members won't come out on dark nights.

This was agreed and looked into, the dress for the photo will be Full Rig with Standards and with decorations worn.

7.5 Branch Patron.

The secretary read a letter from Colonel Stewart OBE, TD, DL who has agreed to be the branch Patron.

Col, Stewart has supported the branch for many years now at our MN parade. Col. Stewart has served on board ships working his way around the world, plus serving on the board of the now defunct Tees and Hartlepool Port Authority as well as being chairman of the HMS Trincomalee trust at Hartlepool. The secretary will write to Col Stewart thanking him for his support of the branch and welcoming him on board.

7.6 MNA AGM Birmingham.

This item was to have been brought up at the last branch meeting but was by passed, however, the chairman asked who would like to go to the MNA AGM 15th October. A possible 9 members will attend and the chairman will drive the bus. This will be paid for by the branch.
